CSIR – Central Food Technological Research Institute, Mysuru, a constituent National Laboratory of Council of Scientific & Industrial Research (CSIR), invites applications from eligible candidates for recruitment of **01 (One)** position of **RESEARCH ASSISTANT (PROJECT ASSOCIATE LEVEL – I)** initially for a period of **01 YEAR** or till the project is over on a temporary contractual basis in the project entitled “**Fine Tuning of Millet Value Chain for Export Markets: Preparation of Export Strategy in Wake of International Year of Millets-2023**” (GAP-0608) funded by APEDA tenable at the Department of **Grain Science Technology**, CSIR-CFTRI, Mysuru, Karnataka.

Essential Qualifications: First Class M.Sc in Food Technology/ Food Science/ Food Science & Nutrition/ Biotechnology/Biochemistry OR First Class in B.E /B.Tech in Food Technology/ Biotechnology and equivalent.

Desirable Experience: Minimum one year R&D experience in the above subjects.

Emoluments: Rs.25,000/- per month (Rupees Twenty Five Thousand only) consolidated.

Terms and Conditions:

1. Candidates should not have exceeded **35** years of age as on **30-09-2021** i.e. the last date of receiving the applications.
2. The engagement of **RESEARCH ASSISTANT (PROJECT ASSOCIATE LEVEL - I)** is exclusively for the above-mentioned research work.
3. The engagement will be contractual and on purely temporary basis for a maximum period of one year or co-terminus with the project, whichever is earlier.
