CSIR – Central Food Technological Research Institute, Mysuru, a constituent National Laboratory of Council of Scientific & Industrial Research (CSIR), invites applications from eligible candidates for recruitment of **01 (One)** position of **JUNIOR RESEARCH FELLOW** initially for a period of **01 Year** or till the project is over on a temporary contractual basis in the project entitled “**Prevention of Cardiometabolic Risk Factors by Multi-Sourced Edible Oil Fortified with Lipid Nutraceuticals: Nutritional Intervention for Obesity-related Complications**”(GAP-0629) tenable at the Department of **Biochemistry**, CSIR-CFTRI, Mysuru, Karnataka.

Essential Qualifications: First class M.Sc. / M. Tech in Food Science/ Food Science Technology including nutrition degree with National Eligibility Tests, i.e., CSIR-UGC NET including lectureship (Assistant Professorship) & GATE.

Desirable Experience: Experience in Fats and Oil analysis, Lipid biochemistry & Animal handling.

Emoluments: Rs.31,000/- (Rupees Thirty One Thousand only) **plus 18% HRA** per month.

Terms and Conditions:

1. Candidates should not have exceeded **28** years of age as on **16-02-2023** i.e. the last date of receiving the applications.
2. The engagement of **JUNIOR RESEARCH FELLOW** is exclusively for the above-mentioned research work.
3. The engagement will be contractual and purely on temporary basis for a period of 01 year or co-terminus with the project, whichever is earlier.
4. The engagement under the externally funded project does not confer any right / claim whatsoever either explicitly or implicitly on the appointee for regular appointment in CSIR-CFTRI, against any post or otherwise under any legal conditions precedent.
5. Performance of the Project Staff will be reviewed every six months. In case the performance is not satisfactory, the fellowship could be terminated with one month's notice or one month's stipend in lieu thereof.
6. No TA/DA will be given to the candidates for attending the interview.
7. If already the candidate is working in CSIR-CFTRI “No objection certificate” from the PI is mandatory at the time of interview.
