CSIR – Central Food Technological Research Institute, Mysuru, a constituent National Laboratory of Council of Scientific & Industrial Research (CSIR), invites applications from eligible candidates for recruitment of **01 (One)** position of **PROJECT ASSISTANT** initially for a period of **08 MONTHS** or till the project is over on a temporary contractual basis in the project entitled “**Global migration studies on plastic and laminates**” (OLP-099) funded by **CSIR** tenable at the Department of **Food Packaging Technology**, CSIR-CFTRI, Mysuru, Karnataka.

Essential Qualifications: Diploma in (Mechanical Engineering) or equivalent degree with good academic records.

Emoluments: Rs.15000/- per month (Rupees Fifteen Thousand only) consolidated.

Terms and Conditions:

1. Candidates should not have exceeded **50** years of age as on **30-07-2021** i.e. the last date of receiving the applications.
