CSIR – Central Food Technological Research Institute, Mysuru, a constituent National Laboratory of Council of Scientific & Industrial Research (CSIR), invites applications from eligible candidates for recruitment of **01** (**One**) position of **PROJECT ASSOCIATE LEVEL - I** initially for a period of **01 Year** or till the project is over on a temporary contractual basis in the project entitled "**Customised anti-fatigue products from coconut and by-products"** (**GAP-630**) at the Department of **Traditional Foods & Applied Nutrition**, CSIR-CFTRI, Mysuru, Karnataka.

Essential Qualifications: M. Sc. in Biotechnology with 01 year research experience.

Job Requirements: Product formulation & analysis behavioural studies on rat models.

Emoluments: Rs.25,000/- (Rupees Twenty Five Thousand only) consolidated per month.
