CSIR – Central Food Technological Research Institute, Mysuru, a constituent National Laboratory of Council of Scientific & Industrial Research (CSIR), invites applications from eligible candidates for recruitment of **01 (ONE)** position of **RESEARCH ASSOCIATE LEVEL - I** initially for a period of **15 Months** or till the project is over on a temporary contractual basis in the project entitled “**Development of immunoassay based multiplexed lateral flow microarray system for detection of multiple mycotoxins**” (HCP-0031) funded by CSIR tenable at the Department of **Microbiology & Fermentation Technology**, CSIR-CFTRI, Mysuru, Karnataka.

Essential Qualifications: Ph.D (Biological Sciences).

Desirable Experience: Experience in Nanotechnology & Biosensor Applications.

Job Requirements: Assistance in developing immunoassay formats for multiplexing analyte detection: Performing ELISA, antibody generation, preparation of nano-conjugates, dipsticks for analyte detection, HPLC, etc., will have to be carried out on routine basis.

Emoluments: Rs. 42,000/- (Rupees Fourty Two Thousand only)/- plus HRA per month.
