CSIR – Central Food Technological Research Institute, Mysuru, a constituent National Laboratory of Council of Scientific & Industrial Research (CSIR), invites applications from eligible candidates for recruitment of **01** (**One**) position of **PROJECT ASSOCIATE LEVEL** - **I** initially for a period of **09 Months** or till the project is over on a temporary contractual basis in the project entitled **"Overall migration studies for evaluation of polymer grades for FDI compliance-12 Grades"** (**SSP-0325**) tenable at the Department of **Food Packaging Technology**, CSIR-CFTRI, Mysuru, Karnataka.

Essential Qualifications: B.E in Polymer Science.
