CSIR – Central Food Technological Research Institute, Mysuru, a constituent National Laboratory of Council of Scientific & Industrial Research (CSIR), invites applications from eligible candidates for recruitment of **01 (One)** position of **JUNIOR RESEARCH FELLOW** initially for a period of **03 MONTHS** or till the project is over on a temporary contractual basis in the project entitled “Evaluating the role of Galactomano- Oligosacchrides as potential therapy for inflammatory bowel disease using omics based approaches” (GAP-0597) tenable at the Department of Microbiology & Fermentation Technology, CSIR-CFTRI, Mysuru, Karnataka.
