CSIR – Central Food Technological Research Institute, Mysuru, a constituent National Laboratory of Council of Scientific & Industrial Research (CSIR), invites applications from eligible candidates for recruitment of **01** (**One**) position of **JUNIOR RESEARCH FELLOW** initially for a period of **05 MONTHS** or till the project is over on a temporary contractual basis in the project entitled "**Design and development of a sustainable process to utilize the agricultural wastes for the production of biodegradable disposable materials and food packaging films" (GAP-0586**) funded by **SERB** tenable at the Department of **Food Packaging Technology**, CSIR-CFTRI, Mysuru, Karnataka.
