CSIR – Central Food Technological Research Institute, Mysuru, a constituent National Laboratory of Council of Scientific & Industrial Research (CSIR), invites applications from eligible candidates for recruitment of **01 (One)** position of **PROJECT ASSISTANT** initially for a period of **12 Months or till the completion of project**, whichever is earlier on a temporary contractual basis in the project entitled **“Characterisation studies and preliminary evaluation of the zero circle films for their suitability to 4 different food groups and their application” (SSP-0333)** tenable at the Department of **Food Packaging Technology**, CSIR-CFTRI, Mysuru, Karnataka.

Essential Qualifications: B. Sc. (Chemistry / Food Science & Technology) or 3 Years Diploma in Engineering & Technology (Food Science & Technology/ Chemical Engineering) and related discipline.

Job Requirements: Characterization studies and Preliminary evaluation of the films. Shelf life studies of the selected film for particular food products. Report submission.

Emoluments: Rs.15,000/- (Rupees Fifteen Thousand only) Consolidated per month.

Terms and Conditions:

1. Candidates should not have exceeded **50** years of age as on **14-07-2022** i.e. the last date of receiving the applications.
2. The engagement of **PROJECT ASSISTANT** is exclusively for the above-mentioned research work.
3. The engagement will be contractual and purely on temporary basis for a period of 12 months or co-terminus with the project, whichever is earlier.
4. The engagement under the externally funded project does not confer any right / claim whatsoever either explicitly or implicitly on the appointee for regular appointment in CSIR-CFTRI, against any post or otherwise under any legal conditions precedent.
5. Performance of the Project Staff will be reviewed every six months. In case the performance is not satisfactory, the fellowship could be terminated with one month's notice or one month's stipend in lieu thereof.
6. No TA/DA will be given to the candidates for attending the interview.
7. If already the candidate is working in CSIR-CFTRI “No objection certificate” from the PI is mandatory at the time of interview.

Applications received after the due date **14-07-2022** will not be considered. The short-listed candidates will be informed about the date of interview through e-mail.
