CSIR – Central Food Technological Research Institute, Mysuru, a constituent National Laboratory of Council of Scientific & Industrial Research (CSIR), invites applications from eligible candidates for recruitment of **01** (**One**) position of **PROJECT ASSOCIATE LEVEL - I** initially for a period of **09 Months** or till the project is over on a temporary contractual basis in the project entitled "**Method of Extraction of soluble and insoluble arabinoxylan from defatted rice bran** (**SSP-0353**) tenable at the Department of Traditional Foods & Applied Nutrition, CSIR-CFTRI, Mysuru, Karnataka.

Essential Qualifications: First Class M.Sc. in Biochemistry or Biotechnology or Life Sciences.

Desirable Experience: Working experience on polysaccharide characterization and pilot scale studies.

Job Requirements:

- a. Optimizing methods at lab scale for the polysaccharide extraction.
- b. Scale-up studies.
- c. Detailed characterization of samples using various analytical techniques.
