CSIR – Central Food Technological Research Institute, Mysuru, a constituent National Laboratory of Council of Scientific & Industrial Research (CSIR), invites applications from eligible candidates for recruitment of **01 (One)** position of **PROJECT ASSOCIATE LEVEL-I** initially for a period of **01 Year**, extendable based on performance or till the project is over on a temporary contractual basis in the project entitled “**Development and Characterization of coconut oil and bioactive compound enriched edible oleogel as a shortening alternate to bakery fats**” (GAP-620) tenable at the Department of Flour Milling, Baking & Confectionery Technology CSIR-CFTRI, Mysuru, Karnataka.

Essential Qualifications: M.Sc. in Food Technology/ Food Science & Nutrition / Chemistry or B.E. / B. Tech in Food Science & Technology / Chemical Engineering (Minimum 55% Marks).

Job Requirements: To carry out R& D activities related to define project.

Emoluments:

1. **Rs.31,000/- per month plus HRA** to Scholars who are selected through (a) National Eligibility Tests CSIR-UGC NET including lectureship (Assistant Professorship) or, GATE or (b) A selection process through National level examinations conducted by Central Government Departments and their Agencies and Institutions
2. **Rs.25,000/- per month plus HRA** for others who do not fall under (1) above.

Terms and Conditions:

1. Candidates should not have exceeded **35** years of age as on **21-07-2022** i.e. the last date of receiving the applications.
2. The engagement of **PROJECT ASSOCIATE LEVEL-I** is exclusively for the above-mentioned research work.
3. The engagement will be contractual and purely on temporary basis for a period of one year, extendable based on performance or co-terminus with the project, whichever is earlier.
4. The engagement under the externally funded project does not confer any right / claim whatsoever either explicitly or implicitly on the appointee for regular appointment in CSIR-CFTRI, against any post or otherwise under any legal conditions precedent.
5. Performance of the Project Staff will be reviewed every six months. In case the performance is not satisfactory, the engagement could be terminated with one month's notice or one month's stipend in lieu thereof.
6. No TA/DA will be given to the candidates for attending the interview.
