CSIR – Central Food Technological Research Institute, Mysuru, a constituent National Laboratory of Council of Scientific & Industrial Research (CSIR), invites applications from eligible candidates for recruitment of **02 (Two)** positions of **PROJECT ASSOCIATE LEVEL-I** initially for a period of **06 MONTHS** or till the project is over on a temporary contractual basis in the project entitled “**Evaluation of RIL algal biomass as a dietary protein source on growth performance, immunological parameters, and meat quality of broiler chicken**”(SSP-0348) tenable at the Department of **Meat & Marine Science**, CSIR-CFTRI, Mysuru, Karnataka.

Essential Qualifications: M.Sc. in Food Science, Food Technology and Microbiology.

Job Requirements: Fresh or Experienced candidate can be considered.
