CSIR – Central Food Technological Research Institute, Mysuru, a constituent National Laboratory of Council of Scientific & Industrial Research (CSIR), invites applications from eligible candidates for recruitment of **01 (One)** position of **PROJECT ASSISTANT** initially for a period of **08 MONTHS** or till the project is over on a temporary contractual basis in the project entitled “**To provide technical support for application of BSG [Brewer’s spent grain (barley)] in food formulations**”- (SSP-318) funded by M/s TBC Breweries & Restaurant LLP, Bangalore tenable at the Department of **Flour Milling, Baking & Confectionery Technology** CSIR-CFTRI, Mysuru, Karnataka.

**Essential Qualifications:** B.Sc (Food Science & Nutrition or Food Science & Technology or equivalent).

**Desirable Qualifications:** M.Sc. ( Food Science & Nutrition or Food Science & Technology or equivalent) or 1-2 years of relevant work experience in reputed R&D organisation.
