CSIR – Central Food Technological Research Institute, Mysuru, a constituent National Laboratory of Council of Scientific & Industrial Research (CSIR), invites applications from eligible candidates for recruitment of **01 (One)** position of **PROJECT ASSISTANT** initially for a period of **03 Months** or till the project is over on a temporary contractual basis in the project entitled “**Analytical characterization of a mango related products**” (SSP-0346) tenable at the Department of **Food Safety & Analytical Quality Control Laboratory**, CSIR-CFTRI, Mysuru, Karnataka.

Essential Qualifications: M.Sc. in Chemistry, Biochemistry.

Job Requirements: Analytical skills, HPLC, MS.

Emoluments: Rs.20,000/- (Rupees Twenty Thousand only) **Plus 16%** per month.

1. Candidates should not have exceeded **50** years of age as on **05-03-2023** i.e. the last date of receiving the applications.
