CSIR – Central Food Technological Research Institute, Mysuru, a constituent National Laboratory of Council of Scientific & Industrial Research (CSIR), invites applications from eligible candidates for recruitment of **03** (**Three**) position of **RESEARCH INTERNS (Project Associate-I**) initially for a period of **06 MONTHS** on a temporary contractual basis at CSIR-CFTRI, Mysuru, Karnataka.

Essential Qualifications: First Class M.Sc in Chemistry/ Food Science / Food Technology / Biochemistry/ Biotechnology or B.E / B. Tech in Mechanical / Production Engineering with good academic records.

Emoluments: Rs.24000/- (Rupees Twenty Four Thousand only) consolidated per month.

Terms and Conditions:

- 1. Candidates should not have exceeded **25** years of age as on **28-09-2021** i.e. the last date of receiving the applications. The upper age limit is relaxable upto **5** years in case of SC/ST, physically handicapped & female candidates & **3** years in case of OBC (Non-Creamy Layer) candidates.
- 2. Performance of the interns will be reviewed every six months. The internship will be terminated with one month of notice or with one month's stipend in lieu thereof, if the progress is found unsatisfactory. The candidates are free to appear for NET/GATE during internship and secure regular fellowship for doing Ph.D.
- 3. No. of positions: 03 (Nos). A panel of candidates qualified on merit but are not selected will be put in the wait list for six months.
- 4. Selection will be made through screening based on overall academic records and online interview (through skype) performance of short-listed candidates.
- 5. Mere fulfillment of eligibility criteria will not entitle the candidate to be called for the interview.
- 6. No TA/DA will be given to the candidates for attending the interview.
- 7. If already the candidate is working in CSIR-CFTRI "No objection certificate" from the PI is mandatory for applying.

Eligible candidates may submit online application at <u>https://patcell.cftri.res.in</u> along with necessary attachments of the certificates in support of date of birth, caste, qualification/experience etc. on or before **28-09-2021** under the subject panel (1) Chemistry or (2) Food Science & Technology Including Nutrition or (3) Biochemistry or (4) Biotechnology or (5) Mechanical or Production Engineering. Applications of those candidates, which are already active in the above panels for Project Associate-I with the above eligibility requirements will be considered by default.

Applications received after the due date i.e. **28-09-2021** will not be considered. The short-listed candidates will be informed about the date of interview through e-mail.
