CSIR – Central Food Technological Research Institute, Mysuru, a constituent National Laboratory of Council of Scientific & Industrial Research (CSIR), desires to engage qualified candidate as Project Associate-I **purely on temporary and contractual basis** for the project entitled “**Sustainable Food Processing for nutritional wellness, safety and food security**” with project number **MLP002608**. - Interested and eligible candidates possessing the aforementioned Essential Qualification may appear for **Walk-in-Interview (in-person mode only)** with Original and self-attested copies of all certificate/testimonials and valid identity proof (Voter ID card/PAN Card/Driving License/Passport/Adhar Card) and one passport size photograph. No candidate will be allowed to appear in the Interview without the Original Certificates.
- Candidates are directed to see the **Annexure-I** for the Application form, download the same and bring it along for submission at the time of the Walk-in-Interview.

3. The age of candidates, educational qualification, experience etc. will be treated on date of **Walk-in Interview**. No TA/DA will be given to the candidates for attending the interview.
- a) In the event of large number of applications, the duly constituted committee will adopt its own criteria for short-listing the candidates to restrict the number of candidates to be called for interview to a reasonable number by any one or more of the following methods:
  - i) On the basis of percentage of marks obtained in the Essential Qualification.
  - ii) On the basis of higher educational qualifications than the minimum prescribed in the advertisement.
  - iii) On the basis of desirable Qualification/ experience.
  - iv) Any other methodology as deemed fit by the Committee
4. The final decision to allow a candidate to appear for interview rests with the Director, CSIR–CFTRI.
5. The total period of engagement of any project personnel under one project and/or combination of different projects, either in the same laboratory and/ or different laboratories of CSIR, cumulatively taken together shall not exceed 06 years.
6. Candidates whose higher degree is ongoing either under AcSIR or under any universities with which CSIR/CSIR laboratories have signed an MoU should bring the NOC in enclosed format (**Annexure-II**) for appearing in the Walk-in-Interview.
7. Selected candidates will not be allowed to discontinue their engagement without seeking prior approval of the Director, CSIR-Central Food Technological Research Institute, Mysuru. In case they wish to discontinue the engagement prior to completion of their tenure, they must submit one month's prior notice indicating specific reason for not continuing or deposit one month's stipend in lieu of the notice period. The engagement shall cease from the date stipulated by the Director while accepting the resignation.
8. The relaxation in the age limit for the candidates belonging to the category of SC/ST/PwBD/Women and the category of OBC shall be 05 years and 03 years respectively or as per Govt. of India instructions issued in this regard from time to time. Candidates belonging to SC/ST/PwBD/OBC should bring their original certificate in the proper format issued by the Appropriate Authority as per the latest instructions issued from time to time on the subject.
9. Candidates are informed that all future notifications/ information regarding this advertisement shall appear/ will be notified in the CSIR–CFTRI Website only. Therefore, candidates are advised to visit the CSIR–CFTRI website from time to time for updates.
10. The decision of the Director, Central Food Technological Research Institute, Mysuru shall be final and binding regarding any matter not specifically stated therein.
11. Canvassing in any form and/or bringing any influence political or otherwise will be treated as a disqualification for the post.
12. The present tenure of the project is approximately four to five years or co-terminus with the project whichever is earlier at CSIR-CFTRI, Mysuru, Karnataka. However, the engagement shall be initially for a period up to 31.03.2027 or Co-terminus with the project from the date of joining. It may be extended or curtailed based on the conduct and the performance of the incumbent as well as requirement of the institute which may be extended further based on recommendations of the Review Committee. However, the engagement will not be beyond the tenure of the project and shall expire automatically on the expiry of project tenure, in which candidate has been selected. Please note that mere engagement has project personnel shall not confer any such personal the right to register for higher degrees or permanent employment in CSIR-CFTRI or CSIR or its laboratories/institutes.

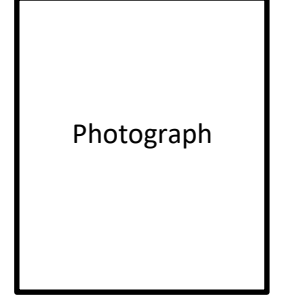
