CSIR – Central Food Technological Research Institute, Mysuru, a constituent National Laboratory of Council of Scientific & Industrial Research (CSIR), invites applications from eligible candidates for recruitment of **01 (One) position** of **PROJECT ASSOCIATE LEVEL - II** initially for a period of **01 Year & extendable up to 03 years** or till the project is over on a temporary contractual basis in the project entitled "Analytical Quality Control & Quality Assurance in Rice Fortification" (GAP-0640) at the Department of Food Safety & Analytical Quality Control Laboratory, CSIR-CFTRI, Mysuru, Karnataka.

Essential Qualifications:

M.Sc.-Chemistry/Bio-Chemistry/Biotechnology/Food Science or Equivalent.

- 2. The engagement of **PROJECT ASSOCIATE LEVEL II** is exclusively for the above-mentioned research work.
- 3. The engagement will be contractual and purely on temporary basis for a period of one year, & extendable up to 03 years or till the project period & co-terminus with the project, whichever is earlier.
