CSIR – Central Food Technological Research Institute, Mysuru, a constituent National Laboratory of Council of Scientific & Industrial Research (CSIR), invites applications from eligible candidates for recruitment of **01 (ONE)** position of **PROJECT ASSOCIATE LEVEL - I** initially for a period of **03 Years** or till the project is over on a temporary contractual basis in the project entitled “**Integrated approaches for bioactives and value addition for floral resources: Floriculture Mission**” (**HCP-0037**) tenable at the Department of **Food Engineering**, CSIR-CFTRI, Mysuru, Karnataka.

Essential Qualifications: M. Sc. / M. Tech. in Food Science & Technology/ Food Technology/ Chemical Engineering/ Food Engineering & Agricultural Engineering.

Job Requirements: To carry out R&D experiments as per the objectives of the funded project.

Emoluments: Rs. 25,000/- (Rupees Twenty Five Thousand only) Plus HRA per month.

1. Candidates should not have exceeded **35** years of age as on **19-07-2023** i.e. the last date of receiving the applications.
2. The engagement of **PROJECT ASSOCIATE LEVEL – I** is exclusively for the above-mentioned research work.
3. The engagement will be contractual and on purely temporary basis for a maximum period of 03 years or co-terminus with the project, whichever is earlier.

5. Performance of the Project Staff will be reviewed every six months. In case the performance is not satisfactory, the engagement could be terminated with one month’s notice or one month’s stipend in lieu thereof.
