CSIR – Central Food Technological Research Institute, Mysuru, a constituent National Laboratory of Council of Scientific & Industrial Research (CSIR), invites applications from eligible candidates for recruitment of **01 (ONE)** position of **PROJECT ASSOCIATE LEVEL - I** initially for a period of **01 Years** or till the project is over on a temporary contractual basis in the project entitled **“Valorization of byproducts from fish industry: Isolation and characterization of glycosaminoglycans for various applications” (GAP-609)** funded by **DBT** tenable at the Department of **Molecular Nutrition**, CSIR-CFTRI, Mysuru, Karnataka.

**Essential Qualifications: First class M.Sc. in Biochemistry/ Chemistry/ Life Sciences.**

**Job Requirements: Isolation and characterization of glycosaminoglycans from fish wastes.**
