CSIR – Central Food Technological Research Institute, Mysuru, a constituent National Laboratory of Council of Scientific & Industrial Research (CSIR), invites applications from eligible candidates for recruitment of **01 (One)** position of **SENIOR RESEARCH FELLOW** initially for a period of **01 Year** or till the project is over on a temporary contractual basis in the project entitled “**Development of an Industrial Scale Cold Plasma Unit for Decontamination of Fruits &Vegetables**” (GAP-0615) tenable at the Department of **Fruit & Vegetable Technology**, CSIR-CFTRI, Mysuru, Karnataka.

**Essential Qualifications:** M.Sc. (Food Science & Technology/ Life Sciences) or B. Tech (Food Engineering/ Agricultural Engineering).

**Job Requirement:**

1. GATE/ NET Lectureship Qualified OR
2. Selected through a National Level Examination process.

**Terms and Conditions:**

1. Candidates should not have exceeded **32** years of age as on **13-03-2022** i.e. the last date of receiving the applications.
2. The engagement of **SENIOR RESEARCH FELLOW** is exclusively for the above-mentioned research work.
3. The engagement will be contractual and purely on temporary basis for a period of one year, which is extendable till the project period and co-terminus with the project, whichever is earlier.
4. The engagement under the externally funded project does not confer any right / claim whatsoever either explicitly or implicitly on the appointee for regular appointment in CSIR-CFTRI, against any post or otherwise under any legal conditions precedent.
5. Performance of the Project Staff will be reviewed every six months. In case the performance is not satisfactory, the fellowship could be terminated with one month's notice or one month's stipend in lieu thereof.
6. No TA/DA will be given to the candidates for attending the interview.
7. If already the candidate is working in CSIR-CFTRI “No objection certificate” from the PI is mandatory at the time of interview.
