CSIR – Central Food Technological Research Institute, Mysuru, a constituent National Laboratory of Council of Scientific & Industrial Research (CSIR), invites applications from eligible candidates for recruitment of **01 (One)** position of **PROJECT ASSISTANT** initially for a period of **01 YEAR** or till the project is over on a temporary contractual basis in the project entitled “**CSIR JIGYASA 2 Virtual Laboratory Integration Project (First Tranche)**”- (**HCP-0101**) funded by **CSIR** tenable at the Department of **Planning, Monitoring & Coordination**, CSIR-CFTRI, Mysuru, Karnataka.

Essential Qualifications: MCA/ M.Sc in (Computer Science/ Computer Application) or B.E. / B. Tech in any Disciplines of Engineering.

Desirable Experience: Working experience in Virtual Lab Software & Arduino Programming etc.
