CSIR – Central Food Technological Research Institute, Mysuru, a constituent National Laboratory of Council of Scientific & Industrial Research (CSIR), invites applications from eligible candidates for recruitment of **03 [Three position(s)]** of **PROJECT ASSOCIATE LEVEL - I** initially for a period of **01 Year & extendable up to 03 years** or till the project is over on a temporary contractual basis in the project entitled “**Analytical Quality Control & Quality Assurance in Rice Fortification**” (GAP-0640) at the Department of **Food Safety & Analytical Quality Control Laboratory**, CSIR-CFTRI, Mysuru, Karnataka.

**Essential Qualifications:** M.Sc. – Chemistry/ Bio-Chemistry/Biotechnology/Food Science or Equivalent.

**Desirable Experience:** Food Analyst Exam qualification, experience in food analysis & instrumental analysis.
