CSIR – Central Food Technological Research Institute, Mysuru a constituent National Laboratory of Council of Scientific & Industrial Research (CSIR), invites applications from eligible candidates for recruitment of 1 (One) position of Junior Research Fellow, initially for a period of one year or till the project is over on a temporary contractual basis in the project entitled *"Investigation of the molecular link between diabetes and its role in the development of non-alcoholic fatty liver disease (NAFLD)" (GAP-0532)* funded by SERB, tenable at the Department of Biochemistry, CSIR-CFTRI, Mysore, Karnataka.

Essential Qualifications:

First class M.Sc. in Biochemistry/Biotechnology with NET/GATE or M.Tech. in Life Sciences and related areas.

Desirable:

One or two years of practical experience in Molecular Biology(gene cloning, gene reporter assays, and gene expression techniques)/Biochemistry. Experience in laboratory animal (Rat/mouse)handling.

Emoluments:

Rs.25,000/-(Rupees Twenty Five Thousand only) plus 20% HRA per month for 1^{st} & 2^{nd} year and Rs.28,000/-(Rupees Twenty Eight Thousand only) plus 20% HRA per month for 3^{rd} year.

- 1. Candidates should not have exceeded **28** years of age as on **03.09.2018** i.e. the last date of receiving the applications. Age relaxation as applicable by Govt. of India rules for SC/ST/OBC and women candidates will be considered.
- 2. The engagement of JRF is exclusively for the above mentioned research work.
- 3. The engagement will be contractual and on purely temporary basis in the externally funded project (GAP-0532) for a maximum period of **one year** and is co-terminus with the project, if the project terminates earlier or till the funds are available, whichever is earlier.
