CSIR – Central Food Technological Research Institute, Mysuru, a constituent National Laboratory of Council of Scientific & Industrial Research (CSIR), invites applications from eligible candidates for recruitment of **01** (**One**) position of **PROJECT ASSOCIATE LEVEL-I** initially for a period up to **MARCH 2024** or till the project is over on a temporary contractual basis in the project entitled **"Capacity building of Food Testing Labs"** (GAP-0639) tenable at the Department of Food Safety & Analytical Quality Control Laboratory CSIR-CFTRI, Mysuru, Karnataka.

Essential Qualifications: M.Sc. Food Science / Microbiology/ Biochemistry/ Molecular biology/ Life Sciences.
