CSIR – Central Food Technological Research Institute, Mysuru, a constituent National Laboratory of Council of Scientific & Industrial Research (CSIR), invites applications from eligible candidates for recruitment of **01** (**One**) position of **PROJECT ASSISTANT** initially for a period of **05 MONTHS** or till the project is over on a temporary contractual basis in the project entitled **"To provide technical support for development of sugar free cookies"**(**SSP-0347**) tenable at the Department of **Flour Milling, Baking & Confectionery Technology**, CSIR-CFTRI, Mysuru, Karnataka.

Essential Qualifications: M.Sc. in Food Science and Nutrition / Food Science & Technology or equivalent.

**Job Requirements:** M.Sc. (Food Science and Nutrition or Food Science & Technology or equivalent) or 1-2 years of relevant work experience in reputed R&D organization .

Emoluments: Rs.15,000/- (Rupees Fifteen Thousand only) Consolidated per month .
