- 1. Candidates should not have exceeded **28** years of age as on **04.11.2019** i.e. the last date of receiving the applications. Age relaxation as applicable by Govt. of India rules for SC/ST/OBC and women candidates will be considered.
- 2. The engagement of JRF is exclusively for the above mentioned research work.
- 3. The engagement will be contractual and on purely temporary basis in the externally funded project **(GAP-0505)** for a maximum period of one year and is co-terminus with the project, if the project terminates earlier or till the funds are available, whichever is earlier.
