CSIR – Central Food Technological Research Institute, Mysuru, a constituent National Laboratory of Council of Scientific & Industrial Research (CSIR), invites applications from eligible candidates for recruitment of **01 (One)** position of **PROJECT ASSOCIATE LEVEL - I** initially for a period of **06 Months, which may be extendable upto December 2023** or till the project is over on a temporary contractual basis in the project entitled “**Empowering growers of ragi and other millets in Odisha state through CSIR-CFTRI scientific intervention**” (GAP-0588) at the Department of **Grain Science Technology**, CSIR-CFTRI, Mysuru, Karnataka.

Essential Qualifications: M.Sc. in Food Science Nutrition / Food Science Technology / Biochemistry/ Nutrition and dietetics.

Job Requirements: To carry out the analysis of millet based products and to assist in technology demonstration to the target group.

Emoluments: Rs.25,000/- (Rupees Twenty Five Thousand only) consolidated per month.
