CSIR – Central Food Technological Research Institute, Mysuru, a constituent National Laboratory of Council of Scientific & Industrial Research (CSIR), invites applications from eligible candidates for recruitment of **01 (One)** position of **PROJECT ASSOCIATE LEVEL - I** initially for a period of **02 MONTHS** or till the project is over on a temporary contractual basis in the project entitled “**Synergizing marine ecology with bioprocessing harnessing marine living resources for products and bioprocesses (BIOPROsmar)**” (MLP-0294) funded by **CSIR** tenable at the Department of **Technology Transfer & Business Development**, CSIR-CFTRI, Mysuru, Karnataka.

Essential Qualifications: M. Sc. (Microbiology /Biochemistry/ Biotechnology).

Job Requirements: Biochemical and Microbiological analysis of microbes, metabolites, experience in animal handling.
