CSIR – Central Food Technological Research Institute, Mysuru, a constituent National Laboratory of Council of Scientific & Industrial Research (CSIR), invites applications from eligible candidates for recruitment of **01** (**One**) position of **PROJECT ASSOCIATE LEVEL** - **I** initially for a period of **02 MONTHS** or till the project is over on a temporary contractual basis in the project entitled "Synergizing marine ecology with bioprocessing harnessing marine living resources for products and bioprocesses (**BIOPROSmar**)" (**MLP-0294**) funded by **CSIR** tenable at the Department of **Technology Transfer & Business Development**, CSIR-CFTRI, Mysuru, Karnataka.

Essential Qualifications: M. Sc. (Microbiology /Biochemistry/ Biotechnology).

Job Requirements: Biochemical and Microbiological analysis of microbes, metabolites, experience in animal handling.

- 5. Performance of the Project Staff will be reviewed periodically. In case the performance is not satisfactory, the engagement could be terminated with one month's notice or one month's stipend in lieu thereof.
- 6. No TA/DA will be given to the candidates for attending the interview.
- 7. If already the candidate is working in CSIR-CFTRI "No objection certificate" from the PI is mandatory at the time of interview.
