CSIR – Central Food Technological Research Institute, Mysuru, a constituent National Laboratory of Council of Scientific & Industrial Research (CSIR), invites applications from eligible candidates for recruitment of **01 (One)** position of **PROJECT ASSOCIATE LEVEL-I** initially for a period of **01 Year** or till the end of project duration, whichever is earlier on a temporary contractual basis in the project entitled “**Identification and analysis of tRNA derived fragments(tRFs) from rice (black, brown, red and white) derived exosome-like edible nanovesicles (ELN) for cancer therapeutics**” (**GAP-0638**) tenable at the Department of **Molecular Nutrition**, CSIR-CFTRI, Mysuru, Karnataka.

Essential Qualifications: M.Sc. in Life Sciences / Biotechnology / Biochemistry / Microbiology.
