CSIR – Central Food Technological Research Institute, Mysuru a constituent national laboratory of Council of Scientific & Industrial Research(CSIR), invites applications from eligible candidates for recruitment of 1 (One) position of Senior Research Fellow, initially for a period of one year or till the project is over on a temporary contractual basis in the project entitled “**Development of bio-fumigation system for safe storage of food commodities against stored product insect pests**”(GAP-0533) funded by MFPI, New Delhi, tenable at the Department of Food Protectants and Infestation Control, CSIR-CFTRI, Mysore, Karnataka.

Essential Qualifications:

First class M.Sc. in Life Science/Food Science with NET/GATE/equivalent exams and two years of research experience with good academic records

OR

First class M Tech. in Biotechnology/Food Technology and two years of research experience with good academic records

Emoluments:

Rs.28,000/- (Rupees Twenty Eight Thousand only) plus 20% HRA per month.

Terms and Conditions:

1. Candidates should not have exceeded **32** years of age as on **01.10.2018** i.e. the last date of receiving the applications. Age relaxation as applicable by Govt. of India rules for SC/ST/OBC and women candidates will be considered.
2. The engagement of SRF is exclusively for the above mentioned research work.
3. The engagement will be contractual and on purely temporary basis in the externally funded project (**GAP-0533**) for a maximum period of **one year** and is co-terminus with the project, if the project terminates earlier or till the funds are available, whichever is earlier.
4. The engagement under the externally funded project does not confer any right/ claim whatsoever either explicitly or implicitly on the appointee for regular appointment in CSIR-CFTRI, against any post or otherwise under any legal conditions precedent.
5. Performance of the SRF will be reviewed every six months. In case the performance is not satisfactory, the fellowship could be terminated with one month's notice or one month's stipend in lieu thereof.
6. No TA/DA will be given to the candidates for attending the interview.
7. If already the candidate is working in CSIR-CFTRI “**No objection certificate**” from the PI is mandatory at the time of interview.
