CSIR – Central Food Technological Research Institute, Mysuru, a constituent National Laboratory of Council of Scientific & Industrial Research (CSIR), invites applications from eligible candidates for recruitment of **03 (ONE)** position of **PROJECT ASSOCIATE LEVEL - I** initially for a period of **02 Years** or till end of the project on a temporary contractual basis in the collaborative project entitled **"Value addition to instant coffee process and other allied activities" (CLP-0023)** tenable at the Department of **Species & Flavour Sciences**, CSIR-CFTRI, Mysuru, Karnataka.

Essential Qualifications: M.Sc in Life Sciences (Biological Sciences) /Chemistry with Minimium 1 years research experience.

## Job Requirements: Analysis, Instruments handling coffee processing.

Emoluments: Rs. 25,000/- (Rupees Twenty Five Thousand Only) consolidated per month.

- 1. Candidates should not have exceeded **35** years of age as on **26-01-2022** i.e. the last date of receiving the applications.

- 3. The engagement will be contractual and on purely temporary basis for a maximum period of one year or co-terminus with the project, whichever is earlier.

- 5. Performance of the Project Staff will be reviewed every six months. In case the performance is not satisfactory, the fellowship could be terminated with one month's notice or one month's stipend in lieu thereof.
- 6. No TA/DA will be given to the candidates for attending the interview.
- 7. If already the candidate is working in CSIR-CFTRI "No objection certificate" from the PI is mandatory at the time of interview.
