CSIR – Central Food Technological Research Institute, Mysuru, a constituent National Laboratory of Council of Scientific & Industrial Research (CSIR), invites applications from eligible candidates for recruitment of **03 (ONE)** position of **PROJECT ASSOCIATE LEVEL - I** initially for a period of **02 Years** or till end of the project on a temporary contractual basis in the collaborative project entitled **“Value addition to instant coffee process and other allied activities” (CLP-0023)** tenable at the Department of **Species & Flavour Sciences**, CSIR-CFTRI, Mysuru, Karnataka.

**Essential Qualifications: M.Sc in Life Sciences (Biological Sciences) /Chemistry with Minimum 1 years research experience.**

**Job Requirements: Analysis, Instruments handling coffee processing.**
