CSIR – Central Food Technological Research Institute, Mysuru, a constituent National Laboratory of Council of Scientific & Industrial Research (CSIR), invites applications from eligible candidates for recruitment of **02 (Two)** positions of **PROJECT ASSOCIATE- I** initially for a period of **10 Months** or till the project is over on a temporary contractual basis in the project entitled **"Disinfestation and management of phosphine resistance insect pests: Design and development of multi-fume grain storage system" (MLP-300)** tenable at the Department of **Food Protectants & Infestation Control,** CSIR-CFTRI, Mysuru, Karnataka.

Essential Qualifications: First Class M.Sc. (Entomology / Zoology / Life Science / Biotechnology).

## Job Requirements:

- 1. Field Sample (Insect pest species) collection from different regions with respect to the project objectives.
- 2. Laboratory R&D work with respect to the project objectives.
