CSIR – Central Food Technological Research Institute, Mysuru, a constituent National Laboratory of Council of Scientific & Industrial Research (CSIR), invites applications from eligible candidates for recruitment of **01 (One)** position of **JUNIOR RESEARCH FELLOW** initially for a period of **ONE YEAR** or till the project is over on a temporary contractual basis in the project entitled “**A Process for Scaling up of the Production of Edible Eicosapentaenoic Acid & Docosahexaenoic Acid Enriched Oil from Fish Industrial Discard**” (GAP-0582) funded by MFPI New Delhi tenable at the Department of Lipid Science, CSIR-CFTRI, Mysuru, Karnataka.

Essential Qualifications: M. Sc/ M. Tech in Food Science & Technology Including Nutrition / Biotechnology & Biochemistry or equivalent with any valid National Eligibility Test (experience in fat & oil analysis will be considered).

Emoluments: Rs.31000/- per month (Rupees Thirty One Thousand only) plus HRA.

1. Candidates should not have exceeded **28** years of age as on **27-08-2021** i.e. the last date of receiving the applications.
2. The engagement of **JUNIOR RESEARCH FELLOW** is exclusively for the above-mentioned research work.
3. The engagement will be contractual and on purely temporary basis for a maximum period of one year or co-terminus with the project, whichever is earlier.
4. The engagement under the externally funded project does not confer any right / claim whatsoever either explicitly or implicitly on the appointee for regular appointment in CSIR-CFTRI, against any post or otherwise under any legal conditions precedent.
5. Performance of the Project Staff will be reviewed every six months. In case the performance is not satisfactory, the fellowship could be terminated with one month's notice or one month's stipend in lieu thereof.
6. No TA/DA will be given to the candidates for attending the interview.
7. If already the candidate is working in CSIR-CFTRI “No objection certificate” from the PI is mandatory at the time of interview.
