CSIR – Central Food Technological Research Institute, Mysuru, a constituent National Laboratory of Council of Scientific & Industrial Research (CSIR), invites applications from eligible candidates for recruitment of **03 (Three)** position of **PROJECT ASSOCIATE LEVEL - I** initially for a period of **06 Months** or till the project is over on a temporary contractual basis in the project entitled “**Immuno modulatory function of nutritional & nutraceuticals for health & wellness (Immunity Mission)**” (HCP-0035) funded by **CSIR** tenable at the Department of **Biochemistry**, CSIR-CFTRI, Mysuru, Karnataka.

Essential Qualifications: Master’s Degree in Natural or Agricultural Sciences / MVSc or Bachelor's Degree in Engineering and Technology or Medicine from recognized University or equivalent.

Desirable Experience: Experience in cell culture, molecular biology & immunology techniques, extraction of bioactives from natural sources, product development, characterization and functional evaluation, handling animal models.

Emoluments: **Rs.31,000/- plus HRA** to Scholars who are selected through National Eligibility Tests (CSIR-UGC NET, GATE etc.) or **Rs.25,000/- plus HRA** to Others.

Terms and Conditions:

1. Candidates should not have exceeded **35** years of age as on **13-11-2021** i.e. the last date of receiving the applications.
2. The engagement of **PROJECT ASSOCIATE LEVEL - I** is exclusively for the above-mentioned research work.
3. The engagement will be contractual and on purely temporary basis for a maximum period of one year or co-terminus with the project, whichever is earlier.
4. The engagement under the externally funded project does not confer any right / claim whatsoever either explicitly or implicitly on the appointee for regular appointment in CSIR-CFTRI, against any post or otherwise under any legal conditions precedent.
5. Performance of the Project Staff will be reviewed every six months. In case the performance is not satisfactory, the fellowship could be terminated with one month’s notice or one month’s stipend in lieu thereof.
