CSIR – Central Food Technological Research Institute, Mysuru, a constituent National Laboratory of Council of Scientific & Industrial Research (CSIR), invites applications from eligible candidates for recruitment of **01** (**One**) position of **PROJECT ASSOCIATE LEVEL-I** initially for a period of **06 Months**, or till the project is over on a temporary contractual basis in the project entitled "**Mobile Processing Unit (MPU) in North East for processing of fruits and vegetables**" (**GAP-0616**) at the Department of **Food Engineering**, CSIR-CFTRI, Mysuru, Karnataka.

**Essential Qualifications:** M.Sc./B.Tech in Life Sciences (Food Science and Technology / Biotechnology/ Microbiology).

Desirable Experience: 1 year or more experience in analytical techniques like HPLC, GC, LC-MS-MS etc.

**Job Requirements:** Assist in experiments related to achieve deliverables of the project. May also involve travel to NE region of country. Demonstration of CFTRI processes and analytical activity will be the major job requirement.

Emoluments: Rs.25,000/- (Rupees Twenty Five Thousand only) consolidated per month.
