CSIR – Central Food Technological Research Institute, Mysuru, a constituent National Laboratory of Council of Scientific & Industrial Research (CSIR), invites applications from eligible candidates for recruitment of **01 (ONE)** position of **PROJECT ASSOCIATE LEVEL - II** initially for a period of **05 Months** or till the project is over on a temporary contractual basis in the project entitled “**Process analysis of corn processing, associated odour issues and suggestion of mitigation measures**”(SSP-324) funded by M/s Cargill India Pvt Ltd tenable at the Department of **Plant Cell Biotechnology**, CSIR-CFTRI, Mysuru, Karnataka.

Essential Qualifications: First class B.E in Biotechnology/ Food Technology / Chemical Engineering.

Desirable Experience: Minimum of 2 year's experience in food and biotechnology field

Job Requirements: Visit to the plant every month with stay for 3 – 4 days. Process analysis of corn wet milling, enzymatic hydrolysis and linking with associated process odours.

Emoluments: Rs.28,000/- plus HRA (Rupees Twenty Eight Thousand Only) per month.
