CSIR – Central Food Technological Research Institute, Mysuru, a constituent National Laboratory of Council of Scientific & Industrial Research (CSIR), invites applications from eligible candidates for recruitment of **01** (**One**) position of **JUNIOR RESEARCH FELLOW** initially for a period of **01 Year** or till the project is over on a temporary contractual basis in the project entitled "**Nano encapsulated Eugenol** (**NE**); its effect on Tau aggregation and related cellular markers of Alzheimer's" (GAP-0591) tenable at the Department of **Molecular Nutrition**, CSIR-CFTRI, Mysuru, Karnataka.

Essential Qualifications: M.Sc. in Biotechnology/ Biochemistry.

- 3. The engagement will be contractual and purely on temporary basis for a period of 01 Year or coterminus with the project, whichever is earlier.

- 5. Performance of the Project Staff will be reviewed every six months. In case the performance is not satisfactory, the fellowship could be terminated with one month's notice or one month's stipend in lieu thereof.
