CSIR – Central Food Technological Research Institute, Mysuru, a constituent National Laboratory of Council of Scientific & Industrial Research (CSIR), invites applications from eligible candidates for recruitment of **01 (One)** position of **JUNIOR RESEARCH FELLOW** initially for a period of **01 Year** or till the project is over on a temporary contractual basis in the project entitled “**Nano encapsulated Eugenol (NE); its effect on Tau aggregation and related cellular markers of Alzheimer’s**” (GAP-0591) tenable at the Department of **Molecular Nutrition**, CSIR-CFTRI, Mysuru, Karnataka.
