CSIR – Central Food Technological Research Institute, Mysuru, a constituent National Laboratory of Council of Scientific & Industrial Research (CSIR), invites applications from eligible candidates for recruitment of **01 (ONE)** position of **PROJECT ASSOCIATE LEVEL - I** initially for a period of **1 Year, extendable based on performance** till the project is over on a temporary contractual basis in the project entitled **“Evaluation of efficacy of selected spice fixed oils for addressing metabolic syndrome” (GAP-0614)** funded by **SERB** tenable at the Department of **Lipid Science**, CSIR-CFTRI, Mysuru, Karnataka.

Essential Qualifications: M.Sc. in Biochemistry/ Biotechnology/ Life Sciences with valid score in CSIR-UGC NET (including lectureship)/GATE/ National Level Examination conducted by Central government.

Job Requirements: Perform experiments on extraction of fixed oils and animal studies on metabolic syndrome.

Emoluments: Rs. 31,000/- (Rupees Thirty One Thousand only) **plus HRA** per month.

Terms and Conditions:

1. Candidates should not have exceeded **35** years of age as on **16-03-2022** i.e. the last date of receiving the applications.
2. The engagement of **PROJECT ASSOCIATE LEVEL- I** is exclusively for the above-mentioned research work.
3. The engagement will be contractual and purely on temporary basis for a maximum period of one year, which is extendable based on performance till the project period and co-terminus with the project, whichever is earlier.
