CSIR – Central Food Technological Research Institute, Mysuru, a constituent National Laboratory of Council of Scientific & Industrial Research (CSIR), invites applications from eligible candidates for recruitment of **01 (One)** position of **PROJECT ASSOCIATE LEVEL-I** initially for a period up to **06 MONTHS**, or till the project is over on a temporary contractual basis in the project entitled **“Investigating the homeostasis of the gut microbiome and its impact on the epigenetic regulation of breast cancer” (MLP-299)** tenable at the Department of Biochemistry, CSIR-CFTRI, Mysuru, Karnataka.

Essential Qualifications: M.Sc. in (Biotechnology) OR BE in Biotechnology.

Desirable Qualifications: Experience in the preparation of functional foods, prebiotic and hands-on experience with microbial techniques.

Job Requirements:

1. Laboratory R&D work with respect to the project objectives.
2. Biochemical and Microbiological analysis, animal handling and experiments.
