CSIR – Central Food Technological Research Institute, Mysuru, a constituent National Laboratory of Council of Scientific & Industrial Research (CSIR), invites applications from eligible candidates for recruitment of **01 (One)** position of **PROJECT ASSOCIATE LEVEL - I** initially for a period of **06 MONTHS** or till the project is over on a temporary contractual basis in the project entitled “**Cloning and Characterization of major genes involved in Stearidonic acid biosynthesis in Buglossoides arvensis and engineered production of Stearidonic acid in Chia (*Salvia hispanica*)**” (GAP-0545) funded by **SERB** tenable at the Department of **Plant Cell Biotechnology**, CSIR-CFTRI, Mysuru, Karnataka.

Essential Qualifications: M.Sc in Biotechnology / Molecular Biology/ Biochemistry / Microbiology or equivalent degree with good academic records.

Desirable Experience: Experience in plant tissue culture and genetic transformation in plants

3. The engagement will be contractual and on purely temporary basis for a maximum period of one year or co-terminus with the project, whichever is earlier.

5. Performance of the Project Staff will be reviewed every six months. In case the performance is not satisfactory, the fellowship could be terminated with one month's notice or one month's stipend in lieu thereof.
6. No TA/DA will be given to the candidates for attending the interview.
7. If already the candidate is working in CSIR-CFTRI “No objection certificate” from the PI is mandatory at the time of interview.
