CSIR – Central Food Technological Research Institute, Mysuru, a constituent National Laboratory of Council of Scientific & Industrial Research (CSIR), invites applications from eligible candidates for recruitment of **01 (One)** position of **PROJECT ASSOCIATE LEVEL-I** initially for a period of **01 Year**, or till the project is over on a temporary contractual basis in the project entitled “**Post-biotics fermentate formulation for the management of diabetes hyperlipidemia and gut health**” (GAP-0633) tenable at the Department of Biochemistry, CSIR-CFTRI, Mysuru, Karnataka.

Essential Qualifications: 1st Class M.Sc. in Biochemistry.

Job Requirements: To carry out R&D under the guidance of PI & submit results periodically to PI.

Emoluments: Rs.25,000/- (**Rupees Twenty Five Thousand Only**) consolidated per month.

1. Candidates should not have exceeded **35** years of age as on **18-03-2023** i.e. the last date of receiving the applications.
