The Director, CSIR-CFTRI, Mysuru invites application from experienced Contract Agencies/Firms for EXPRESSION OF INTEREST for "Construction of 50KLD capacity Sewage Water treatment (STP) near IFTTC Hostel at CSIR-CFTRI, Mysuru"." The details are below:

- Experienced Contract Agencies/Firms are requested to submit the EOI along with details of firm profile, firm registration certificate/Contractor's License, GST, PAN, technical expertise and details of completed Sewage treatment plant or Effluent Treatment Plant works including connected Civil and Electrical works <u>during the</u> last five years, ending on the last day on the month previous to the one in which tender is being invited at Government and Reputed Private Organisations with satisfactory completion certificate from the respective clients in the Cover-I.
- 2. The Estimated cost of work is Rs 21,70,000/- (Rupees Twenty One lakhs Seventy Thousand only)
- 3. EOI shall be submitted through online at CPP Portal: https://etenders.gov.in/eprocure/app by the tenderer. The instructions for the submission of EOI are available CPP on the portal i.e. https://etenders.gov.in/eprocure/app under the "Instruction for Online Bid Submission". All the intending tenderers are requested to go through these instructions before submitting EOI and advised to visit again CPP Portal regularly till closing date of submission of tender for any corrigendum/ addendum/ amendment. - 4. The received documents of the tenderers will be scrutinised and eligible tenders will be short listed. Further, limited tender will be invited for Technical and Price bid from the shortlisted tenderers. The Director, CSIR-CFTRI reserves the right to accept in full or in part or reject all or any application without assigning any reasons whatsoever and no correspondence will be entertained in this regard.
- 5. The tenderer is to indicate the name & telephone numbers of issuing agency of the completion certificates to enable the verification of the documents, if necessary. It may be noted that even after opening of price bid, the credential submitted found to be false / forged the offer submitted shall be rejected out rightly. No further clarification will be sought from the tenderers.
- 6. No tenderer shall be permitted to apply for EOI/tender for works in the concerned unit of C.S.I.R. in which a relative is posted in the grade between Controller of Administration and Junior Engineer, (both inclusive). He shall also intimate the name of persons who are working with him in any capacity or subsequently employed by him and who relatives are as mentioned above.

Note: A person shall be deemed to be a relative of another if, and only if, (a) they are members of a Hindu undivided family or (b) they are husband and wife or (c) the one is related to the other in the following manner: father, mother (including step mother), son (including step son), Son's wife, Daughter (including step daughter), Father's father, Son's son, Son's son's wife, Son's daughter, Son's daughter's husband, Daughter's husband, Daughter's son, Daughter's son's wife, Daughter's daughter, Daughter's daughter's husband, Brother (including step brother), Brother's wife, Sister (including step sister), Sister's husband. Relationship declaration should be submitted/uploaded in the cover I as per Annexure-B.

- 7. Before tendering, the tenderer shall inspect the site to fully acquaint himself about the conditions of accessibility of site, nature and extent of ground, working condition of site and locality including stacking of materials, installations off tools and plants (T&P) etc., conditions affecting accommodations and movement of labour etc. required for the satisfactory execution of contract. No claim whatsoever on such accounts shall be entertained by the employer under any circumstances.
- 8. Not more than one EOI/tender shall be submitted by one contactor or contractors having business relationship. Under no circumstance will father and his son(s) or other close relations who have business relationship with one another (i.e when one or more partner(s)/director(s) are common) be allowed to EOI/tender for the same contract as separate competitors. A breach of this condition will render the EOI/tenders of both parties liable to rejection.
- 9. For any queries relating to the EOI/Tender Document and the terms and conditions content therein should be addressed to COA, CSIR-CFTRI, Mysuru.
- 10. Tender/EOI Liable for Rejection.

Tender/EOI is liable for outright rejection if on opening it is found that —

(a) The Tenderer has not strictly followed the procedure laid down for submission of EOI/tender.

(b) If the EOI/tender is CONDITIONAL

(c) The Tenderer has not uploaded the documents or Failed to fill the prescribed format.

(d) Any other ground as decided by the TOC in view of deviation from EOI/Tender Document
