Those who have been declared qualified in the Trade Test for various post codes of Technical Assistant will only be allowed to appear for the Competitive Written Examination and will be given the option to download the Admit card.

The detailed information regarding reporting time and address of the venue and other instructions will be available in the Admit Card. Those candidates are requested to download the Admit card from CFTRI recruitment portal (i.e. <https://recruitment.cftri.res.in>) w.e.f 15.12.2025 (10:00 AM). CSIR-CFTRI does not assume any responsibility for the candidates not being able to download the admit card & produce the same at the time of the written test, on account of any reason(s), whatsoever.

There will be three Papers (Paper- I, II & III). Paper-II and Paper-III will be evaluated only for those candidates who secure the minimum threshold marks (as decided by the selection committee as below) in Paper-I. However, the final merit list will be prepared only on the basis of the marks obtained by the candidates in Paper-II and Paper-III.

All the candidates are also hereby informed that the category wise threshold marks (Cut off Marks), as decided by the Selection Committee and approved by the Competent Authority, for the Paper-I are as under:

Paper-I for the Post of Technical Assistant		
Sr. No.	Category of posts	Minimum Threshold Marks
1	Unreserved [UR]	35%
2	Economically Weaker Sections [EWS]	30%
3	Other Backward Classes (Non-Creamy Layer) [OBC(NCL)]	30%
4	Scheduled Caste [SC]	25%
5	Scheduled Tribe [ST]	25%
6	Persons with Benchmark Disabilities (OH/HH)	25%

Merely obtaining the minimum threshold marks in the Competitive Written Examination will not confer any right to claim for appointment to the post. The final selection will be made purely based on the marks obtained by the candidates in Paper-II and Paper-III of the Competitive Written Examination which comprises of those who have qualified in Paper-I.
