An applicant must fulfill the criteria listed in the table below in order to be eligible for appearing in the interview.

Sl. No.	Criteria	Applicable to
1.	Short listing of candidates for Biological Sciences is based on method 1 from AcSIR guidelines. Applicants qualifications and secured <b>Valid Fellowship</b> (JRF/SRF of various funding agencies, e.g. CSIR, UGC, DBT, DST etc. or INSPIRE or other equivalent fellowships) are prerequisite.	<b>Faculty of Sciences</b>
2.	Sponsored candidates: Candidates should be from reputed <b>Industries/Institute</b> and also have authenticated document from the Industries/Institute stating that they are willing to sponsor the candidate for their Ph.D. research under AcSIR and prior approval from Director, CSIR-CFTRI.	<b>Sponsored candidates</b>
3.	Candidates should be regular employee at CSIR-CFTRI and should have prior approval of Academic committee / Director.	<b>Internal Candidates (in service)</b>
4.	Candidates should be working as Project JRF/SRF at CSIR – CFTRI, in a project of minimum duration of 3 years with at least more than 2 Years of the project period remaining. Such candidate should have NET (LS)/GATE for M.Sc./B.Tech and M.Tech.	<b>Internal Candidates (Students)</b>
5.	Project Assistants/ Research Interns should have 02 years of research experience <b>by the time of admission</b> and have one publication (as the First or Second Author in an SCI journal) and should be working in a project. Further, he/she should be having a duration of not less than one year left <b>from the date of admission</b> .	
6.	M.Tech degree holders working as Project Assistants (Project Associates) / Research Interns / Project JRF/SRF in R & D projects having a duration of minimum 2 years in CSIR – CFTRI	
7.	The total number of candidate shortlisting is as per the ratio indicated in AcSIR ordinance 2017 (1:4 to 1:7)	<b>All fellowship holders</b>

**Short-listed Candidates shall have to attend the interview on producing VALID Fellowship Award Letters from the funding agencies with clear mention of monthly stipend, contingency grant and stipulated tenure of Fellowship.**
