1. Kind attention of the candidates, who had applied for various post(s) of Technical Assistant vide advertisement No. Rec.36/2018 and the list of shortlisted candidates to appear for the Trade Test vide notification cited under Ref. (1).

2. This is for the information of all concerned that the syllabus for Trade Test and Written Test (Paper-III) for the post of Technical Assistant has already been notified under Ref. (2). The post code wise list of Provisionally eligible candidates being called for the Trade Test, is enclosed herewith as Annexure.

4. Admit Card Form to the Provisionally eligible candidates are being sent to their registered email id provided by them in their applications. In case, any candidate has not received the admit card form by 14th November 2024, he/she may contact through email at recruit@cftri.res.in.

5. The candidates must bring the following Original Documents along with the admit card form to verify the information furnished in the application at the time of appearing in the Trade Test:

- 10th/ Matriculation or Equivalent Certificate for Age Proof.
- All Original Educational Qualifications (from SSLC/ Matriculation onwards) along with Mark Sheets.
- All Original experience certificates, as proof of experience. (If applicable)
- Latest/Valid Community or Category certificates etc., as per Gol central format, in case of SC/ST/OBC(NCL)/PwBD/Women (Widows/Divorced/Judicially Separated) categories, if claimed.
- Valid Photo Identity proof in original such as PAN Card/Passport/Driving License /Voter Identity card/Aadhar Card/E-Aadhar Card with photograph issued by State or Central Govt.
- In case the candidate employed under Central/State Govt./Autonomous Body/PSU, a "No Objection Certificate" from the present employer to appear for Trade Test.
- Any other Original document in support of the claim made in the application, as applicable.

6. Please note that the candidates, claimed for availing the reservation benefit of OBC/SC/ST must ensure that he/she possess the caste/community certificate as per Gol central format only and OBC candidates do not fall in creamy layer. Additionally, where subject to production of OBC/SC certificate in the prescribed format of Government of India mentioned as remarks against each candidate in the CSIR-CFTRI Web Notifications dated 25/03/2021 & 24/08/2021 are mandated to provide the OBC/SC certificate at the time of Document verification for appearing in the trade test, failing in which they will not be allowed for trade test.

7. All the candidates are also hereby informed that the category wise threshold marks (Cut off Marks), as decided by the Selection Committee and approved by the Competent Authority, for the trade test are as under:

8. It is to be noted that at the time of attending the trade test, the shortlisted candidates for Post Codes TA-06, TA-08 & TA-09 should select one of the subjects specified against the post code in the advertisement where more than one subject is mentioned as an essential qualification. The subject so chosen by the candidate should be one of the subject(s) mentioned in their Mark sheet/Certificate of essential educational qualification i.e. B.Sc.

9. Further, the candidate needs to submit an option form at the time of attending the Trade Test, and the subject chosen in the option form will be final and irrevocable, i.e. binding upon the candidate. Candidate will be allowed to appear for the trade test in the subject chosen in the option form only.

10. Those who qualify in the Trade Test will be invited for a competitive written examination and the candidate will be considered for selection only based on the prescribed subject chosen in the option form at the time of Trade test for that particular post. Hence, the candidates shall carefully select the subject paper at the time of attending the Trade Test.

11. The candidature of the below-mentioned Eligible candidates for the Trade Test is provisional and is subject to fulfilling the minimum eligibility criteria as mentioned in advertisement no. Rec.36/2018 and verification of all relevant original documents. The shortlisted candidates belonging to SC/ST/OBC/PwBD/Ex-Servicemen/Women (Widows /Divorced /Judicially Separated) categories their candidature is subject to submission/verification of latest certificates in the prescribed Gol format.
12. If at any stage of the recruitment process, it is found that the applicant has furnished any incorrect/false information or suppressed any material fact(s) or does not fulfil any of the conditions of the eligibility such as essential qualification, prescribed age limit, category/community etc., for the posts notified vide CSIR-CFTRI advt. No. Rec 36/2018, the candidature is liable to be cancelled without any further notice. Candidates are, therefore, advised to check carefully and satisfy themselves that they fulfil all conditions as stipulated in the advertisement for the post they have applied for before attending the Trade Test. Further, if any of these shortcoming(s) is/are detected after appointment in CSIR-CFTRI, his/her services are liable to be summarily terminated.
13. No TA/DA will be paid by CSIR-CFTRI for the above said Trade Tests. The candidates are advised to make their own arrangements for stay, if required.
14. Candidates are advised to check their emails as well as CSIR-CFTRI website <https://cftri.res.in> regularly for the updates. No Interim or Telephonic enquiry or correspondence will be entertained.

**GENERAL INSTRUCTIONS TO THE CANDIDATES RELATING TO THE TRADE TEST FOR
THE POST OF TECHNICAL ASSISTANT vide CSIR-CFTRI Advt. No. Rec.36/2018**

1. No candidate will be permitted to appear for Trade Test without the Admit Card form and supporting original documents for verification.
2. Candidate shall bring any one of the original valid photo identity proof i.e. Passport/Voter Id Card/Aadhar Card/Driving License and PAN Card or any photo ID card issued by any Government Agency / Authority for verification. The candidates coming without photo identity proof will not be permitted to appear for Trade Test.
3. Candidates are advised to make their own arrangements for accommodation since CSIR-CFTRI does not provide accommodation to candidates. Candidates are also advised to plan their itinerary in such a way that they should be able to be present for the Trade Test at the designated centre during the very next day of the scheduled date of Trade Test also, in case need arises for so.
4. Candidates are also advised to read carefully the conditions of CSIR-CFTRI Advt. No. Rec.36/2018 & subsequent Web notifications dated [25/03/2021](#), [24/08/2021](#), [24/10/2024](#) & 08/11/2024 before they plan to appear for the Trade Test.
5. Candidates will be allowed only to report at the centre notified at the scheduled reporting time of the trade test. Any request for a change of date/session/centre/venue will not be entertained under any circumstances. Candidates, in their own interest, may ensure the location of their centre/venue one day before the date of the Trade Test and make necessary arrangements to reach the reporting Centre well in advance before the Trade Test for their convenience.
6. Candidates in their own interest should be present in the Reporting Centre half an hour before the reporting time of the Scheduled date of the Trade Test.
7. Candidates will have to bring their own stationery, viz., black/blue Ball point pen, Pencil, Sharpener, Eraser etc. Candidates should not carry a paper inside the Examination Hall.
8. Every candidate will be required to sign on the photo-bearing attendance sheet against his/her Reg. No./Application No. before the beginning of the Trade Test.
9. On completion of the Test, the Candidates shall remain seated at their desks and wait until the scripts/Job works are collected and accounted for.
10. No candidate shall leave the Examination Hall without proper permission of the Supervisor/Invigilator and without handing over the scripts/Job works to the Supervisor/Invigilator. Candidates failing to deposit the same shall be disqualified and may be liable to suitable action as per rules.
11. No candidate shall be permitted to leave the Examination Hall before completion of the Trade Test.
12. Silence must be observed in the Trade Test Hall and candidates are required to maintain discipline and decorum for smooth conduct of the Trade Test.

13. Candidates may please note that the issue of Admit Card/Attending the Trade Test does not constitute any right for appointment to the posts for which they applied/offer of employment in CSIR-CFTRI/CSIR.
14. In case of any injury during the Trade Test, CSIR-CFTRI will not bear any expenses towards the treatment of the same. However, First Aid facilities will be made available at the time of Trade Test. Candidates attending the Trade Test shall not be entitled to claim any compensation from CSIR-CFTRI, for any injury /loss/mishap that may occur during their Trade Test.
15. Candidates are advised in their own interest not to bring any valuables/costly items to the venue as arrangements for safe keeping cannot be assured, and this Institute will not be responsible for any loss in this regard.
16. Candidates are strictly instructed not to carry any communication device like Mobile Phones, Bluetooth, Earphones, Microphone, Health Band etc., and any other item which could be used for unfair means for hiding communication devices like cameras, blue tooth devices etc. at the time of Trade Test. Any candidate found resorting to any unfair means or malpractice or any misconduct while appearing for the Trade Test including giving/receiving help to/from any Candidate during the Trade Test will be disqualified.
17. Anyone found to be disclosing, publishing, reproducing, transmitting, storing or facilitating transmission and storage of test contents in any form or any information there in whole or Part thereof or by any means verbal or written, electronic or mechanical or taking away the papers supplied during the Trade Test are found to be unauthorized possession of test content will be debarred or disqualified from the test and suitable legal action will be taken on the candidate.
18. The possibility of occurrence of some problem in conducting of the Trade Test cannot be ruled out completely which may impact test delivery and/or result from being generated. In that event, every effort will be made to rectify such problem which may include movement of candidates, delay in Trade Test, conduct of a re-Test is at the absolute discretion of the test conducting body. Candidates will not have any claim for a re-test. Candidates not willing to move or not willing to participate in the delayed process of test delivery shall be summarily rejected from the process.
19. Merely obtaining the minimum threshold marks in the Trade Test as mentioned above will not confer any right to claim for appointment to the post. The final selection will be made purely based on merit, i.e., Paper-II and Paper-III subject to meeting the minimum threshold marks in Paper-I.
20. In case verification is not completed at the time of Trade Test due to paucity of time, the same will be carried out in the Institute at a later date with intimation to the candidates through email/by post/telephone (as available in their application) and for which the candidates have to appear with the original documents for verification failing which their candidature will be cancelled.
21. Candidates should strictly comply with the directions given by the authorities of CSIR-CFTRI at the time of Trade Test. Any unruly behaviour / disturbance at the venue will be viewed seriously and may entail expulsion from the Test or disciplinary/legal proceedings against the concerned candidates. In case of any disputes, the decision of The Director, CSIR-CFTRI is final and binding on all the candidates.

22. Canvassing in any form by or on behalf of the candidates or to bring political or other outside influence with regard to their selection/recruitment shall be considered as disqualification.
23. The decision of the Competent Authority, CSIR-CFTRI, is final and binding for all candidates on any points not mentioned in the preceding instructions.
