- 4. ID Proof: The applicant has to upload a valid Identity Card (Driving License / Aadhaar Card / Voter ID / PAN Card / Passport / Bank Passbook with photo). In the absence of ID proof, the registration will be cancelled.
- 5. Online Sessions: The program will be conducted through online on Microsoft Teams. It is recommended to use a Laptop/Desktop computer installed with Microsoft Teams and a reliable internet connection to attend the sessions.
