Sub: Disposal of Representations received from candidates against CSIR-CFTRI web notification dated 14.10.2024 for the posts of Junior Secretariat Assistant (Gen, F&A, S&P) and Junior Stenographer – reg.

A list of provisionally shortlisted candidates (to be called for Open Competitive Written Examination against CSIR-CFTRI Advt. No Rec.02/2021) was notified vide web notification dated 14.10.2024 with stipulation that "Representations, if any, of the candidates can be submitted only through the Recruitment Portal <https://recruitment.cftri.res.in> duly enclosing proof in support of his/her claim on or before 21.10.2024 (till 17:00 hours)".

In response, 83 number of representations (i.e. 37 no. against the post code of JSAG, 13 no. against the post code of JSAF, 27 no. against the post code of JSAP & 6 no. against the post code of STEN) were received through the above portal within the stipulated period. All these representations were placed before the committee for their consideration and recommendations. The Competent Authority has approved the recommendations of the committee and in light of the above recommendations and decisions taken thereon, the representations for the above post codes stand disposed of accordingly. The decision on the representations is being communicated individually through email to the candidates concerned. The representations received other than through Recruitment portal have not been considered. No further representations to this effect will be entertained.

All concerned may also kindly note that the Provisional List of shortlisted candidates to be called for Open Competitive Written Examination against CSIR-CFTRI Advt. No Rec.02/2021 for the posts of Junior Secretariat Assistant (Gen, F&A, S&P) and Junior Stenographer vide Notification No. FT/15(1182)/2021/E-I dated 14.10.2024 is final, and no further representation/request in this regard will be entertained. Venue and date for the Written Examination for the above posts will be notified on the CSIR-CFTRI website <https://cftri.res.in> in due course of time.

Rec.02/2021 and verification of all relevant original documents at the time of Written Examination/Proficiency test. The shortlisted candidates belonging to SC/ST/OBC(NCL)/PwBD/Ex-Servicemen/Women (Widows/Divorced /Judicially Separated) categories their candidature is subject to submission/verification of latest certificates in the prescribed Gol format.
